Salted Township Roads, used 6 loads of salt. Dug out 2 soft spots on Wildwood Rd. and put down number 4 and then 2A limestone. Also put 6" under drain in some spots. Cut 24 downed trees for the month from high winds. Finished painting the lower garage. Patched holes all around the Township. Graded ditches on Upper Wildwood. Cleaned drains all around the Township. Replaced all the boards on the bleachers at Bradshaw Park with treated lumber. Used 435 gallons of diesel fuel and 66 gallons of gasoline. Submitted by Wayne Young, Road Foreman.

E. Engineer Report April 2023

Monthly Engineer's Report was presented and is attached with meeting packet. **Motion by Emmett Santillo to authorize LSSE to prepare contract documents and advertise for the 2023 Road Program as well as the Bologne Valley Bridge Replacement. John Axtell seconded. All in favor.** Emily updated the Supervisors that there was no grant money awarded to North Sewickley Township applications for the bridge replacement. Emily suggested placing the advertisement simultaneously with the road program for cost savings. Emily believes the bridge project is going to be a higher cost than originally projected due to the length of time that has passed. Emily is working on the easements with Ryan Long. Emmett updated the public on the road tourn from March 3, 2023. We project to tar and chip and/or pave to stay within the liquid fuels budget. LSSE will come back in May with final docs on the Road Program. LSSE added another section to their report regarding funding opportunities.

F. Ryan Long, Solicitor Report

Emmett Santillo made the motion to approve the Short Term Rental Ordinance that was made available for public comment. Tom Roush seconded. All in favor.

All in favor. The memorial/pavilion area is to commemorate fallen employees and it is the Township intent to rent the pavilion.
- B. Emmett Santillo made the motion to table the discussion on walkie talkies for the road department. Tom Roush seconded. All in favor.
- C. Emmett Santillo made the motion to close the office on election day, May 16, 2023, road department and sewer/water field workers will remain in operation. John Axtell seconded. All in favor.
